### Education & Experience

Amy Oros earned a BA in Psychology from Berry College (1993) and graduated summa cum laude with an MS in Oriental Medicine and BS in Professional Health Studies from the Florida College of Integrative Medicine (2011). This four-year program consisted of 3,400 hours of postgraduate study in Oriental Medicine including over 1,000 hours of clinical practice. Amy is board certified as a Diplomate in Oriental Medicine (including Acupuncture and Chinese Herbology) and is certified in Acupoint Injection Therapy.

Amy's training includes adjunctive therapies such as Neural Therapy, herbal medicine, auriculotherapy, cupping, dietary and lifestyle recommendations, Tui Na, Qi Gong, and moxibustion. She is a licensed Doctor of Oriental Medicine in Florida and a licensed Acupuncturist in Colorado. Neither of these licenses have ever been suspended or revoked. Amy is a member of the National Certification Commission for Acupuncture and Oriental Medicine (NCCAOM). She co-founded the Brevard (County FL) Alliance for Military Acupuncture (BAMA) in 2012 providing free treatments to military members.

Amy is operating as a mobile clinic only at this time. She complies with the rules and regulations publicized by the Colorado Department of Public Health and Environment including the proper use of needles and the sanitation of acupuncture treatments. Only single-use, disposable, factory-sterilized needles are used by this practitioner.

Follow-up Treatment	\$95 plus cost of herbal formulas as needed
In-Home surcharge	\$55
Travel	\$4 per 10 minute increments
Herbal consultation only	\$45 plus cost of herbal formulas
